Dr. Catherine Wehlburg Named 39th President

In just over the 200 years Athens State University has been in existence, Dr. C a t h e r i n e Wehlburg is only the third woman to serve as President. The Athens State University Board of Trustees made the official appointment at the May 2024 meeting.

Dr. Wehlburg had been serving as the Interim President since Dr. Philip Way stepped down in January 2023. She was first



hired by Athens State to serve as the University's Provost.

Board Chair, Senator Arthur Orr, expressed great

confidence in Dr. Wehlburg's abilities to take on her new role. He states, "The Board believes Dr. Wehlburg has the willingness to make any needed changes and adjustments in the months ahead to take Athens State to heightened lev-

els not previously seen."

College of Business Introduces a New Certificate Program

In Spring 2024, the College of Business launched a new undergraduate certificate program in Space Systems Management.

This certificate allows students to choose five courses in aviation and/or space systems management. Space systems courses cover topics such as rocket and spacecraft propulsion systems, spacecraft environments, and aerospace flight risk management. Aviation courses include aviation safety and security management, aviation law, and federal aviation regulations management.

"We live in a highly technical, aerospace-oriented community," said Dr. Wayne McCain, Professor of Management of Technology. "The certificates are a good introduction to the topic and allow a student to start immediately and get a credential that they can add to their resume that might help them get employment at one of those prime contractors or even with the government—the Army or NASA, for instance."

Certificate programs are aimed at students who have a gap in their educational learning. Dr. McCain claims about 75% of students enrolled in the certification program are already in the field of aviation or space systems. They are working toward additional academic credentials that can pair with their current jobs. "It gives them the

chance to really learn a lot of the background and academic aspects of what they're already doing at work," stated Dr. McCain.

Athens State is committed to making the program a hands-on experience. Students are working on several projects that include building a small satellite, working on an experimental aircraft, a Mars life support backpack and a scuba diving breathable mechanism.

Experiential Learning is a process through which students develop knowledge, skills, and values by applying theory and academic content to real-world experiences within the classroom, community, or workplace. It encompasses internships, undergraduate research, handson activities, community service, among other creative and professional work experiences.

In 2023, two COB professors

completed the Experiential Education Academy (EEA) offered by the Society for Experiential Education (SEE). The curriculum provides participants with knowledge, skills, and competence to strengthen experiential education within their classrooms. Graduates must complete 6 workshops within the curriculum. Ms. Kim Bell and Dr. Kim Roberts graduated from the academy in 2023. They teach statistics and leadership/management courses, respectively.

Students Earn Lean Six Sigma Certifications

The Operations Management minor and the Advanced Manufacturing Management programs in the College of Business include courses in Lean Six Sigma. In Fall 2023, ten students earned their Lean Six Sigma White Belt certification. A Council for Six Sigma Certification (CSSC) Certified Lean Six Sigma White Belt designation reflects knowledge by the individual of the basic definition, history, and structure of the discipline. Students who achieved this designation are Javian Conley, David Craft, Jennifer Daugherty, Kc Englebert, Carletta Hannan, Candace Sanchez-Harper, Jeremy Hughey, Reanna Johnson, Jamie Kelly, and Rebecca Malone Williams.

In Spring 2024, four students earned their Lean Six Sigma Yellow Belt Certification. A Yellow Belt participates as a core team member or subject matter expert (SME) on a project or projects and may be responsible for running smaller process improvement projects. Students earning the Yellow Belt certification are Brandon Bennett, Javian Conley, David Craft, and Rebecca Malone Wil-

liams. In addition, David Craft displayed his Lean Manufacturing project "Application of 5S to Operations Utility Boxes at a Chemical Manufacturing Facility" at the Honors Program Scholarly and Creative Work Showcase in April.

Athens State's M.S. in Strategic Leadership and Business Analytics has been ranked as high as #3 in the country on AnalyticsDegrees.org's list of the Most Affordable Online Masters in Business Analytics Degree Programs. Perhaps the most consistently awarded program in the College of Business is our B.S. Logistics and Supply Chain Management. and #6 The Best Online Bachelor's in Supply Chain Management Degree Programs.

In all College of Business programs, faculty are able to utilize their own first-hand industry experience from successful careers in their discipline to further provide a hands-on learning approach for students.

COB Hosts International Lecturer

On Thursday, June 6, Dr. Chao-Chang Arthur Chen delivered a presentation on "Trend of Semiconductor Manufacturing Technology and Future AI Integration." His presentation covered advanced manufacturing technologies for semiconductor production and the emerging trend of integrating advanced chips into artificial intelligence systems.

Dr. Chen is a globally recognized scholar in the chemical mechanical polishing (CMP) process for precision engineering in advanced manufacturing. He serves as the CEO of

the CMP Innovation Center at the National Taiwan University of Science and Technology. Dr. Chen holds a PhD in mechanical engineering from the University of Wisconsin-Madison. He previously held the position of deputy CEO at the National Measurement Laboratory of Taiwan. Recently, he founded OmniMeasure, a semiconductor testing service company in Taiwan. Dr. Steve Wang, College of Business Associate Professor of Advanced Manufacturing Management, hosted the event.

Teaching with AI

During the 2024 academic year, ATLIS, the Writing Center, Client Services, and Kares Library collaborated with the faculty of the Learning Resources Committee to explore innovative approaches to teaching with Artificial Intelligence (AI). The Learning Resources Committee facilitated two pilot groups of faculty through a "Teaching with AI" course developed by the Auburn University Biggio Center for the Enhancement of Teaching and Learning that has been featured in *The*

Chronicle of Higher Education, Inside Higher Ed and was awarded the 2024 Outstanding Program: Noncredit Award by the UCPEA. Additionally, both the SEC and the Alabama Community College System have adopted the course, empowering instructors to "demystify the AI landscape and harness its abilities within the classroom and beyond" (Auburn.edu).

Several of the College of Business faculty completed the course during the past year. They are Ms.
