

2015-16 Athens State University Foundation Faculty Awards Nomination Packet

The Athens State University Foundation sponsors two faculty awards annually - the *Teaching Excellence Award* and the *Distinguished Research/Creative Work Award*. The recipient of each award will receive \$1,000.

These awards are for truly distinguished teaching and research/creative work. Students, faculty, and administrators are encouraged to nominate those faculty members who exemplify excellence in their teaching and scholarly work.

Students, faculty, and staff are encouraged to review the criteria for each award and consider possible candidates to nominate.

Nomination Process

- o Individuals making nominations for either award should complete the **nomination form** (attached at the end of this document) and a **letter of nomination** that addresses the nominee's qualification for the award based on the criteria for each outlined on pages 2 and 3 of this document.
- Submit the printed nomination form and letter of nomination to the Associate VP of Academic Affairs (Belinda Krigel) by <u>February 24, 2016</u>.
- ° The nominee along with their department chair and dean will be notified of the nomination by the Associate VP. The nominee will need to assemble the **Nomination Dossier** and submit a printed copy to the Associate VP of Academic Affairs no later than **April 6, 2016**. (Dossier requirements are listed below).
- Obssiers will be reviewed by the **Faculty Awards Committee** and the winner announced at the 2016 Athens State University Honors Convocation. The Faculty Awards Committee membership includes the Associate VP of Academic Affairs, previous year winners of the awards, Library Director, Staff Senate Presiding Officer, and one faculty member from each college.

Distinguished Scholarly/Creative Work Award

Criteria

Candidates for the *Distinguished Scholarly/Creative Work* award must be full-time faculty members whose university careers are distinguished by truly outstanding scholarly or creative activity. Nominees for the award should have achieved recognition from peers and/or officials of peer-reviewed scholarly or creative work that:

- ° are credible, significant to the university or college, and be ongoing and current;
- enhance faculty expertise in their discipline;
- ° make contribution to the faculty member's discipline;
- ° is published or placed;
- ° results in lectures, presentations, etc.;
- use validated scholarly methodologies and analysis. For creative work, there should be evidence of originality of work;
- ° is clear and complete;
- contributes to the University, regional, national or international intellectual communities while increasing the visibility of the University.

Nomination Dossier Requirements

(to be completed by nominee)

- Nominee's description (two-page maximum) of scholarly/creative work
- Copies of recent scholarly work or photos of creative work
- ° Up-to-date curriculum vitae with emphasis on scholarly activities and/or creative productions
- Letter of support from the department chair or dean (one page maximum)
- ° Two recommendations from peers (one-page maximum each). At least one of the recommendations must come from a peer within the same discipline at another university

Teaching Excellence Award

Criteria

Candidates for the *Teaching Excellence Award* must be full-time faculty members whose university careers are distinguished by truly outstanding performance in the classroom, and/or laboratory setting. Nominees for the award should have achieved recognition from students, colleagues, and administrators in the following areas:

- superior knowledge of subject matter;
- teaching philosophy that exemplifies Athens State University's vision and mission statement and goals of the instructor's college and department;
- o focus on student learning and the integration of theory & practice;
- ° imaginative, effective, and rigorous methods of presenting course materials and evaluating learning;
- abiding concern for students' advancement in a discipline, in the university, in the workplace, in the community;
- ability to engender and nurture values of learning such as curiosity, objectivity, enthusiasm, fairness, and critical thinking in students;
- ° record of producing students who by virtue of outstanding teaching, achieve great success throughout their university careers;
- opedagogical/andragogical diligence, dedication, versatility, generosity, and creativity.

Nomination Dossier Requirements

(to be completed by the nominee)

- Nominee's statement which will include their teaching philosophy (two-page maximum).
- Our Up-to-date curriculum vitae with emphasis on instructional activities.
- Letter of support from the department chair or dean (one page maximum).
- Peer recommendations (limit of two, one-page maximum each). Recommendations must come
 from Athens State University faculty members with at least one coming from within the discipline.
- ^o Letters of support from students currently enrolled at Athens State University (limit of three, one page maximum each) and from former students (limit of three, one-page maximum each).
- ° A summary sheet listing (1) courses taught during the past three years (identified by course number and title), (2) the terms during which those courses were taught, and (3) the number of students in each course.
- ° The last three faculty performance evaluations.
- A list of professional development efforts (with dates and venue) which may include professional conferences, seminars, workshops, and training sessions in his/her discipline, education in general, or on technologies and innovations used in instruction such as Blackboard, Wimba, Collaborate, etc.
