OLD BUSINESS

NEW BUSINESS

New Programs

College of Education

- 1. Bachelor of Science in Education -Educational Studies. This program is being developed for people who work in educational services, but do not need to be certified to teach.
- 2. Master of Education Career and Technical Education. The College of Education has had overwhelming requests to offer this program. Athens State currently offers a Bachelor of Science in Education in Technical Education with 5 different options available.

College of Arts & Sciences/College of Business

1. Collaborating to offer a Bachelor of Science in Globalization

Degree Works

Degree Works is the new degree-audit and advising program that will be implemented before fall semester.

Policy Development

The Office of Academic Affairs is working closely with the Faculty Senate in the creation, review and approval of policies and proposals. Policies and proposals are sent to the Presiding Officer of the Faculty Senate who forwards to the appropriate faculty standing committee.

Professional Development Grants

This program would allow faculty members to apply for funding of professional development, equipment and/or technology. The proposal has been sent to Faculty Senate for review.

Community College Visits

Dr. Ron Ingle, Dr. Jackie Smith and the College Deans will begin visiting the "academic teams" at various community colleges in August. The managers at the Athens State University centers have been asked to look at the needs of the community college students and to try unique scheduling on their campuses based on these needs.

Center for Lifelong Learning

Assistant Professor Kim Bell, College of Business, is serving as the interim director of the Center for Lifelong Learning (CLL). Professor Bell and the CLL staff are looking at additional ways the CLL can be of assistance to the community. Professor Bell distributed and briefly review new developments and offerings at the CLL.
