- Employee completes payment for coursework based on the adjusted tuition discount assigned to the Learning Partner Employee/Student.

Continuing Students

Review & Register:

1. Employee Student should review <u>Degree Works</u> each semester and register using the online registration portal on their Athens State Online account for the class(es) toward their degree.

2. Employees complete the "Learning Partnership Tuition Discount Form" that will be available from their employer's HR Department or Athens State's website: <u>Tuition Discount Form</u>

- 3. HR Manager or designee will forward the form by email to: business.office@athens.edu for processing in the Athens State University Business Office.
- 4. Employee completes payment for coursework based on the adjusted tuition discount assigned to the Learning Partner Employee/Student.

Advising Information: Contact the Student Success Center for assistance with advising and registering for classes.

To be eligible for the tuition discount, the student/employee or dependent must maintain at least a "C" (2.0 on a 4.0 scale) in the courses for which he/she receives tuition assistance. A minimum Grade Point Average (GPA) of 2.00 must be maintained in order to be eligible for the tuition discount. Failure to meet this grade minimum will result in the student's having to pay tuition for the courses taken until his/her average grade is a "C" or better.
